What is this product?

Type: Shares of a Sub-Fund of Amundi Funds, an Undertaking for Collective Investments in Transferable Securities (UCITS), established as a SICAV. Term: The term of the Sub-Fund is unlimited. The Management Company may terminate the fund by liquidation or merger with another fund in accordance with legal requirements.

Objectives: Seeks to increase the value of your investment (mainly through capital growth) over the recommended holding period, while achieving an ESG score greater than that of the benchmark.

Benchmark: 80% MSCI Emerging Markets Index; 20% MSCI Frontier Markets Index. Used for performance comparison and for determining ESG outperformance.

Portfolio holdings: The sub-fund is actively managed. It mainly invests in equities of companies in emerging markets. The sub-fund may or may not hedge currency risk at portfolio level, at the discretion of the investment manager. The Sub-Fund makes use of derivatives to reduce various risks (hedging), manage the portfolio more efficiently, and gain exposure (long or short) to various assets, markets and other investment opportunities. The sub-fund intends to use total return swaps and securities financing transactions (see "More about Derivatives and Techniques" section).

Management process: The investment uses a combination of overall market data and fundamental analysis of individual issuers to identify equities with superior long-term prospects. The focus is on companies benefiting from the establishment of new trade routes and associated capital investment flows arising out of a geopolitical re-definition of the commercial landscape and set to improve infrastructure, connectivity and economic cooperation for emerging markets. The investment manager is not constrained by the benchmark for the construction of the portfolio and makes its own investment decisions. The sub-fund promotes ESG characteristics pursuant to Article 8 of the Disclosure Regulation.

Intended Retail Investor: This product is intended for investors, with a basic knowledge of and no or limited experience of investing in funds seeking to increase the value of their investment over the recommended holding period with the ability to bear losses up to the amount invested.

Redemption and Dealing: Shares may be sold (redeemed) as stated in the prospectus at the respective dealing price (net asset value). Further details are provided in the Amundi Funds prospectus.

Distribution Policy: As this is a non-distributing share class, investment income is reinvested.
