

## Financial Notice:

Alignment with the ESMA Guidelines on Funds' Names,<sup>1</sup> changes to exclusion criteria within the non-financial approach and change of name.

The unitholders and shareholders of the following Undertakings for Collective Investment ("UCIs")\*, the management company of which is Amundi Asset Management, are advised of changes coming into effect on 30 April 2025.

Pursuant to the new European Union guidelines (ESMA34-472-440) published on 14 May 2024, on funds' names using ESG or sustainability-related terms, companies deriving part of their revenues from fossil fuels (such as gas and oil), will be excluded from the portfolio of these mutual funds (these are the exclusions set out in Article 12(1)(a) to (g) of Commission Delegated Regulation (EU) 2020/1818 of 17 July 2020 supplementing Regulation (EU) 2016/1011 of the European Parliament and of the Council).

With regard to the mutual fund AMUNDI AFD AVENIRS DURABLES\* and the SICAV DANONE.COMMUNITIES\* more specifically, the underlying UCIs also apply exclusions to companies deriving part of their revenues from fossil fuels (such as gas, oil, etc.). These exclusions are set out in Article 12(1)(a) to (g) of Commission Delegated Regulation (EU) 2020/1818 of 17 July 2020 supplementing Regulation (EU) 2016/1011 of the European Parliament and of the Council as regards minimum standards for EU Climate Transition Benchmarks and EU Paris-Aligned Benchmarks.

In any event, these UCIs may nevertheless invest in bond issues intended to specifically finance green, social and/or sustainable projects, issued by investee companies linked to activities that are not deemed to be aligned with the Paris Climate Agreement.

The unitholders and shareholders of the following UCIs and their feeder funds, are also advised that these UCIs will no longer exclude the "E" and "F" ESG scores (on the Amundi scale ranging from A, the best score, to G, the worst score):<sup>2</sup>
