The Swiss Representative of the Company, Société Générale, Paris, Zurich Branch, hereby informs shareholders in Switzerland of the following:

The board of directors of the Company (the "**Board**") has decided to change the index of the Sub-Fund (the "**Index**") and to update accordingly its denomination and SFDR classification, as detailed below (the "**Changes**"). The Changes will become effective as of **22 October 2026** (the "**Effective Date**") and reflected in the next approved Prospectus.

- **Shareholders who do not agree with the terms and conditions of the Changes have the right to redeem their shares at any time free of charges (excluding fees to cover divestment fees) within 30 calendar days from the date of this notice. Nevertheless, placing an order on the secondary market will trigger costs over which the Management Company has no influence.**
- **Please note that Shares that were purchased on the secondary market cannot generally be sold back directly to the Company. As a result, investors operating on the secondary market may incur brokerage and/or transaction fees on their transactions. These investors will also trade at a price that reflects the existence of a bid-ask spread. Such investors are invited to contact their usual broker for further information on the brokerage fees that may apply to them and the bid-ask spreads they are likely to incur.**
- **In case where the Shareholders agree with these changes, no action is required from the Shareholders.**

Following the implementation of the Changes, the Prospectus and the Key Information Documents of the Sub-Fund will be amended accordingly.

The Prospectus, the Key (Investor) Information Documents, the Articles of Incorporation and the most recent annual and semi-annual report of the Company are available free of charge from the Representative in Switzerland.
