As a security measure, if your password is input incorrectly three times, your Internet account access and online transaction capabilities will be disabled. To reactivate these features, call an Amundi Pioneer representative at 1-800-225-6292. The system will warn you that you have input an incorrect password and let you know how many tries you have left.
