If your entity is classified as a C-Corporation under the Internal Revenue Code, you may qualify for the 70% corporate Dividends Received Deduction (DRD), which allows you to deduct a portion of the income dividends (including short-term capital gain distributions but not long-term capital gain distributions) you received from your Pioneer fund accounts during 2020.

Below are the percentages of each Pioneer fund that was eligible for DRD in 2020:
