ATTENTION: Important tax reporting information for investors in tax-exempt mutual funds

For tax year 2022, mutual funds are required by the Internal Revenue Service to report all tax-exempt and taxable distributions paid on Form 1099-DIV. If the amount of tax-exempt interest dividends and/or taxable distributions paid to you in 2022 was \$10.00 or more, you will receive an IRS Form 1099-DIV from Amundi US.

Tax-exempt interest dividends are reported in Box 12 on Form 1099-DIV. The amount shown in Box 12 on Form 1099-DIV should be reported on your Federal income tax return on IRS Form 1040 or Form 1040A. Amounts reported in Box 12 on Form 1099-DIV are NOT subject to Federal income tax. The amount of the tax-exempt interest paid, if any, subject to the Alternative Minimum Tax is reported in Box 13 on Form 1099-DIV. For more information on how to report Alternative Minimum Tax, please refer to the Instructions for IRS Form 6251.

Any taxable distributions paid by your fund in 2022 are required to be reported in Boxes 1a, 1b, 2a, 2b, 2d or 9 on Form 1099-DIV, depending on the type of taxable distribution paid.

Please consult with your tax professional to determine if you must file Form 6251 or for more information about tax-exempt interest dividends.

Remember

Tax-exempt income distributions are not subject to Federal income tax. You need to report this amount for informational purposes only on your Federal income tax return.
