Form 1099-DIV reports the tax character of all distributions paid to you in 2020. Form 1099-B reports your gross proceeds, as well as any reportable cost basis, related to the sale of fund shares during the year.

You should use the information reported to you on Form 1099-DIV and Form 1099-B to prepare your income tax return since Amundi US will be sending that data to the Internal Revenue Service. If you choose to import your tax documents into a tax software product, please verify that the information reported to you on Form 1099-DIV is complete; otherwise, manual entry of missing tax information may be required. 2020 1099-DIV tax forms for Pioneer funds other than Real Estate Shares were mailed in late January.
